SCOPE OF WORK:

The Academy of Tribal Languages & Culture (ATLC), Bhubaneswar is an autonomous body under the ST & SC Development, M&BC Welfare Department, Government of Odisha. It is focused on preserving and promoting the languages and culture of Odisha's tribal communities through language documentation, educational resources and research. Sargiful is an annual festival organized by ATLC on behalf of the administrative department to celebrate the creativity and talents of tribal students across the state. Held in December, this festival provides students with a platform to showcase their artistic and cultural achievements and includes an annual publication highlighting their work. Every year, around 1200 students from SSD Department-run schools participate in this event. This year the event has been scheduled from December 18-20, 2025 at Adivasi Exhibition Ground.

Academy of Tribal Languages & Culture intends to procure Sweaters, T-shirts, Jersey and Shoes of good quality as per the content designed for State Level Students Festival Sargiful-2025 through reputed Firms/ Agencies.

TERMS OF REFERENCE

DELIVERABLES:

- Supply of high-quality branded Sweaters, T-shirt, (with Sargiful logo branding for approximately 1100 students. The indicative costs are @ Rs.700/- for sweaters, @ Rs. 500/- for T-Shirts.
- Supply of high-quality Branded Jersey (Sports half sleeve T-shirts & Half paint with Sargiful logo branding) @ Rs.700/- and Branded Shoes @ Rs. 1100/- for 128 Nos. of boys and girls.
- Delivery to be completed within one week of receiving the work order.

APPLICATION PROCEDURE

- I. Interested Agencies / Firms having valid registration certificate including GST registration are required to submit the necessary documents in the prescribed format along with their price offer in sealed covers.
- II. The quotations must be submitted via Registered Post/Speed Post only.
- III. The bidding firms should submit their bid in two separate sealed envelopes on or before the due date.
 - a. Envelope ONE marked in bold as Technical Bid shall contain all supporting documents to ascertain the eligibility of the firm to participate in the bidding process as per Annexure-I.
 - b. Envelope TWO marked in bold as Financial Bid shall contain a schedule of prices for the proposal as per Annexure-II.
 - c. Both sealed envelopes need to be put in one large envelope which should be super scribed as 'Procurement of quality apparel for Sargiful-2025'
 - d. The envelopes are to be addressed to the Member Secretary, ATLC, Adivasi Exhibition Ground, Unit-1, Bhubaneswar-751 009.
 - IV. Quotations that are incomplete or received after the stipulated timeline are subject to rejection.
 - V. The Authority reserves the right to alter/cancel any terms of the Quotation Call Notice without assigning any reason thereof.

OTHER TERMS & CONDITIONS:

- 1. Firms/ Vendors shall submit bid proposals with requisite documents & bid processing fee of Rs 1000/- in shape of DD.
- 2. A Demand Draft worth Rs.50,000/- (Rupees Fifty Thousand Only), drawn in favor of the Member Secretary, ATLC towards EMD from any Nationalized bank, should be submitted along with the sealed quotation. This amount will be returned to the unsuccessful bidders after the selection process. The amount will be returned to the successful bidder after supply of quoted items/ after completion of terms and conditions of this quotation call notice.
- 3. The proposals are to be properly sealed & signed by the bidders.
- 4. The technically qualified bidders must produce the samples of the Items before opening of the Financial Bid. The Tender Committee reserves the right to accept or reject any sample on the basis of quality.
- 5. After selection of the bidder, the authority will issue "Letter of Award" in favour of the L-1 bidder for signing the Contract Agreement. In case the L-1 bidder fails, the L-2 bidder shall be invited to supply goods at the prices of L-1. If, the negotiation with L-2 fails, the bidding procedure will be cancelled and fresh bids shall be invited.
- 6. The authority reserves right to empanel more than one firm, if required.
- The contract will remain valid for the financial year 2025-26, which may be extended for another year, subject to satisfactory performance of the Agency and requirement of ATLC.
- 8. The timeline to be given for delivery of goods is to be strictly adhered to. Any delay shall render the bidder liable for damages & there after the authority holds the options for cancellation of the contract and complete the same through any other Agency. The failure on bidder's part to supply the indents as per the guidelines will enforce a penalty@1% per week subject to maximum of 10% of the contract value.
- 9. All legal disputes are subject to the jurisdiction of Civil Courts of Bhubaneswar only.
- 10. The authority reserves the right to accept or reject any or all proposals.

ELIGIBILTY CRITERIA:

- 1. The Firm/ Vendor should have valid GST registration Certificate.
- 2. The firm must have a fully operational office in Odisha
- 3. The Firm should not have been black listed by any Govt./PSU/Govt. Organization.
- 4. The Firm should have relevant work experience for minimum of 3 years ended with 31st March 2025.

METHOD OF SELECTION:

In this regard, the decision of the committee on sample selection will be final. The firms whose samples will qualify the minimum standards will be considered for financial bidding. Selection will be made on basis of least cost method.
